# • PERSONNEL ECONOMIC RELIEF ALLOWANCE (PERA)

PERA shall be given at Two Thousand Pesos (P2,000) per month to supplement pay due to the rising cost of living per DBM Budget Circular No. 2009-3.

## UNIFORM ALLOWANCE

A uniform allowance equivalent to Six Thousand Pesos (P6,000) is granted to all officers and regular employees per year. The uniform allowance shall be paid directly to the supplier or manufacturer of uniform.

## • RETIREMENT PLAN

All employees of LLFC are automatically considered members of the Retirement Benefit Plan and are entitled to receive its benefits in accordance with its policies and guidelines. Membership thereof shall continue until the member retires, resigns or is separated from the service, or upon transfer to another office, or upon his death.
