**BACKGROUND**

As part of the Board-approved Information Systems Strategic Plan (ISSP) for CY 2026, the Corporation initially identified the procurement of mid-range desktop computers to support its operational requirements. However, in line with Memorandum Circular No. 114, which directs government agencies to adopt a four-day work week with a work-from-home arrangement every Friday to promote energy efficiency and flexible work arrangements, the Corporation has reassessed its ICT requirements and determined the need to transition from desktop computers to laptop units. This shift is necessary to support workforce mobility, ensure continuity of operations, and enable employees to effectively perform their duties both within and outside the office.

**OBJECTIVES**

The objective for the procurement is to acquire new Laptop units that can handle the latest applications and software programs of LLFC for use by LLFC employees in their daily task and operations in line with Memorandum Circular No. 114.
